Sector Partnership Training Revised and Re-issued: October 24, 2019

(former Issue Dates: January 24, 2019; Revised & Re-Issued June 4, 2019)

On behalf of the Mayor's Workforce Development Board (MWDB), the Detroit Employment Solutions Corporation (DESC) is seeking proposals from qualified residents through a sector partnership model, using a combination of public and private funding. DESC seeks programs that result in 80% of graduates obtaining training-related employment with career advancement opportunities. Sector partnership training programs have the following features: 1) they are led by multiple employers that make active contributions; 2) employers and data drive the occupations to be targeted, the volume of training and the credentials and content of training; and 3) career advancement opportunities are supported.

This FOA will be used to select providers for DESC's supplemented Eligible Training Provider List (ETPL) as allowed by WIOA and to also award funds via direct contracts.

DESC re-released the FOA on October 24th, 2019 with the following changes:

- Expanded focus on foundational skills training, with an emphasis on serving PATH participants
- Overview of best practice models for building foundational skills
- DESC may establish cost reimbursement contracts with applicants selected to provide foundational skills programs
